**WESTERN HILLS BASEBALL AND WESTERN HILLS LITTLE LEAGUE
WAIVER & RELEASE**

1. PROGRAM: We desire that our child participate in the Western Hills Little League baseball program, the Western Hills Pony League including Southwest PONY interlocking league or the Western Hills Colt Program.

2. MEDICAL CONDITIONS: We understand the nature of the physical demands of the Little League, Pony League, and Colt League baseball. My child has the following medical and physical conditions which might affect or limit his or her participation: (List conditions)

3. RISKS: We understand that participation in youth baseball involves inherent risks of injury, maybe serious. We understand that reasonable procedures are employed by the volunteers of Western Hills Little League and West Austin Youth Association, but we further understand that those organizations, their officers, agents, representatives, and employees can not be held responsible for injuries to the participants. We hereby assume all risks normally incidental to youth baseball. We hereby acknowledge that injuries to participants of youth baseball are foreseeable.

4. RELEASE: We unconditionally waive and release the Western Hills Little League (WHLL) and the West Austin Youth Association (WAYA), their directors, officers, agents, volunteers, and employees from any and all claims, rights, or causes of action which we now have or may have in the future for any injuries, expenses, loss of compensation, loss of service, or other damages (general, special or damages to personal property) which we may experience as a direct or indirect result of the use of the services, facilities, instruction, or premises of the Western Hills Little League (WHLL) or the West Austin Youth Association (WAYA) or as a direct or indirect result of our child's participation. THIS RELEASE SPECIFICALLY INCLUDES AND APPLIES TO ANY INJURIES RESULTING FROM NEGLIGENCE OR ANY NEGLIGENT ACT OR OMISSION ON THE PART OF WESTERN HILLS LITTLE LEAGUE OR WEST AUSTIN YOUTH ASSOCIATION.

5. INDEMNIFICATION: We unconditionally promise and agree to indemnify WHLL or WAYA and their directors, officers, agents, volunteers, and employees and to hold said persons harmless from any and all claims, rights, or causes of action which may be asserted against WHLL or WAYA, their officers, agents, volunteers, or employees by any person as the result of our child's participation in Little League baseball or as the result of any injuries, expenses, loss of compensation, loss of experience as a direct or indirect result of the use of the services, facilities, instruction or premises of WHLL or WAYA. This agreement to indemnify includes any and all money paid or owed by WHLL or WAYA, its directors, officers, agents, volunteers, or employees to, or are charged by, any person (whether by virtue of a settlement or in litigation) including attorney's fees for any parties to the claim, demand, or litigation. THIS AGREEMENT TO INDEMNIFY INCLUDES AND APPLIES TO ANY CLAIMS, RIGHTS OR CAUSES OF ACTION WHICH MAY BE ASSERTED AGAINST WHLL OR WAYA FOR INJURIES, EXPENSES, LOSS OF COMPENSATION OR LOSS EXPERIENCE INCLUDING THOSE ARISING FROM THE NEGLIGENCE OR ANY NEGLIGENT ACT OR OMISSION OF WESTERN HILLS LITTLE LEAGUE OR WEST AUSTIN YOUTH ASSOCIATION.

6. MEDICAL ACCIDENT COVERAGE: We fully understand that we must provide medical and hospitalization insurance to cover any medical expenses incurred by our child as a result of participation in WHLL or WAYA Little League and Pony League baseball. We understand that we will be fully responsible for payment of any such medical expenses.

7. CONSIDERATION: We hereby acknowledge the validity and adequacy of the consideration for this release being the offering and provision by WHLL and WAYA of the Little League Baseball program.

8. BINDING EFFECT: This agreement is binding upon us and upon our heirs, assigns, dependents, personal representatives, attorneys, and our estates. This agreement is also binding upon our child on whose behalf it is executed and upon any legal guardian thereof.

9. ENTIRE AGREEMENT: This document constitutes the entire agreement between WHLL and WAYA and the undersigned regarding the subjects covered hereby. All previous agreements, oral and written, are superseded and there exist no further oral or written representations, promises, assurances, or statements of any kind affecting this agreement except those which are expressly set forth in this document.
